Confidentiality Statement

All Rape Crisis employees and volunteers are bound by confidentiality within the agency, with the following exceptions:

- ★ Threat of harm to self or others
- ★ Child abuse (past or present)
- ★ Abuse of vulnerable adult (i.e., elder abuse)

Community Awareness

Other volunteer opportunities are available. Volunteers staff information booths at community events, assist with fundraising activities and occasionally volunteer in the office.

STAR Volunteers

Sexual Trauma Advocate & Resource (STAR) Volunteers are specially trained advocates who respond to the needs of sexual assault victims and their families. Much of this response is done by telephone; however, sometimes volunteers accompany a victim at the hospital.

The STAR Volunteer's purpose is to support the victim, their family, and friends in their time of need. That support may be a listening ear, a resource for information, and/or education on the recovery process.

Volunteer Qualifications

STAR Volunteers must:

- ★ Be 18 years of age or older
- ★ Successfully pass a criminal background check
- ★ Successfully complete the initial 10 hour Sexual Assault Trauma Advocate & Resource (STAR) training provided by Rape Crisis Intervention Service (RCIS) as well as attending continued training opportunities periodically each year
- ★ Reside within one hour of the Carroll Hospital Center
- ★ Have a valid drivers license
- ★ Have access to reliable and immediate transportation and phone
- ★ Be dependable! STAR Volunteers are responsible for direct client contact and responding to the Rape Crisis Hotline
- ★ Be available by phone and respond to hotline calls and accompaniments when scheduled for duty
- ★ Agree to abstain from drugs and alcohol when on call

Required Training

Volunteers must complete the 10 hour STAR course for certification and successfully complete a clinical assessment by an Agency Therapist before having contact with clients or staffing the hotline. A written and oral examination conclude the certification process.

Each volunteer is also required to complete 6 hours of additional training each calendar year. These trainings will be offered throughout the calendar year by RCIS and other training opportunities will be available outside RCIS.

Staffing the Hotline

RCIS provides Carroll County with a 24-hour rape crisis hotline. Volunteers are expected to staff the hotline by responding to calls from the answering service. Volunteer shift coverage includes week nights, weekends, and holidays.

Safety is important to us. No volunteer is ever asked to do anything they feel is unsafe. Volunteers meet with clients at the hospital, police barracks or at the office. For safety and privacy reasons, we do not provide transportation or personal phone numbers to our clients.

Can I volunteer if I am a survivor of sexual assault?

Some of our volunteers are survivors of sexual assault. If you are a survivor of sexual assault and have worked through the trauma, your experience could be valuable as a STAR Volunteer.

When are STAR Meetings Held?

Volunteer meetings are held bi-monthly and attendance is a priority. At these meetings volunteers receive continued education and sign up for hotline shifts.

What kind of contact and support can I expect from the staff?

Volunteers will have contact information to reach staff and experienced volunteers while on duty. Volunteers have the opportunity to receive additional information and support by contacting the office after a shift. Agency Therapists and other staff are available for de-briefing after cases. Volunteer meetings are also a key opportunity to receive support and feedback from staff.

What kind of time commitment can I expect?

Volunteers are asked for a one-year commitment to RCIS. A minimum of 25 hours on call per month is required. A hospital visit may take up to three hours, while a phone call may take only a few minutes.

How do I apply?

Prospective volunteers must submit an application, provide two references, and complete an initial interview with the Hotline Services Coordinator.
